Simultaneously this launches a very important gaslighting technique:



- Some school districts are passing policies that will allow school counselors and social workers to take your child to receive puberty blockers and cross-sex hormone drugs without parental consent.


This is why parents need to keep their child away from all “mental health professionals” in K-12.
