I am writing to you all to express how upset and angry people are with this and this man preaching to our kids in Church. many of us Christians are very upset and disgusted by this and the fact the Williamson county churches and events are held by people like this that prefer to dilute and put down kids, parents, and staff that are a part of the LGBTQ community to make them feel as if they are being sinful or not worthy enough to be able to join these events.
