Thank you for reaching out, Trish. I saw the communication sent by WMS to the 6th graders yesterday and remembered that your daughter was in that group. Though not every student was in close contact with the positive case, we felt it was important to notify the entire grade level as they could have experienced more casual contact in the hallways or cafeteria. I know you have probably watched the board meeting at this point, but our district health team evaluated the percent of individuals on campus that have access to vaccinations and its impact on COVID spread, all the detail surrounding the CDC recommendations, the CDC view on the impact of vaccine access for adults, the CDC view on those at the middle and high school levels and masks, local conditions for small children vs. older and those who have been vaccinated as well as other factors. This was all taken into consideration in their recommendation to the board. The board did discuss 6th grade, but ultimately didn't make the decision to require masks but to recommend for that grade band.
